MEET YOUR NEW PRESIDENT!



Bruce Wallace is the 52nd President of the Canyon Lake Men's Golf Club. He was born in the United States on January 12, 1951 in Dayton, Ohio, the first of five (5) children and spent most of his childhood years traveling and living around the world. He's lived in Holland, Germany, and Turkey internationally and Colorado, Florida, Ohio, Arizona, Delaware and California. While living in Holland at age three (3), he was run over by a motorcycle (no permanent "physical" damage). His father was a pilot in the United States Air Force and a "test pilot", retiring as a LtCol. His mother was an Australian "war bride". During his father's military career, he also visited Saudi Arabia, India, Pakistan, Philippines, Viet Nam, Thailand, Australia, New Zealand and American Samoa. He says that he has been in all 50 states, except Wisconsin (he doesn't like cheese or the "Packers"). In his early

teens, the family returned to the States and landed in California, where he graduated from Garden Grove High School as class Valedictorian (a pretty smart guy) in 1969. He was on the high school track and golf team and went to the CIF golf playoffs as a senior.

Bruce received an appointment to the United States Air Force Academy and studied there from June 1969 to March 1971, before deciding that a military career was not for him. But staying in one university was not just an experience at the Air Force Academy. He also found reasons to attend the University of Colorado, the University of South Florida and Arizona State University before finally obtaining his BS in Management in 1983 from the University of Phoenix.

In 1973, he became involved in the building materials business, originally with his Dad, and later, two brothers, specializing in windows and doors. After cutting his teeth in the industry in Florida, he relocated to Tempe, AZ **in 1976** and spent the next 27 years developing the family window and door company until 2003, at which time he and his brothers sold the company. For the next five (5) years he served as a consultant to *Pella Window & Doors*, before fully retiring and doing something the opposite of most retirees, he moved from Arizona to California and landed in Canyon Lake. He was no stranger to the area, having played as a guest in the Men's Golf Club Member/Guest several times with an old friend Joe Young.

In addition to his talent at golf, that motorcycle incident at three (3) years of age didn't deter him from becoming a motorcycle enthusiast, having been to the Sturgis Motorcycle Rally in South Dakota five (5) times. He also sports a "Wallace Clan" tattoo on his left shoulder and sometimes the sun reflection off the earring in his left ear is distracting to his fellow golfers. Other than riding a motorcycle, having a tattoo and an earring, he is a pretty normal guy, the kind of guy you'd elect to be President of your Men's Golf Club for 2021.

Bruce is not one to do something impetuously. He and his wife Karen were married in 2006, although they have been together 31 years. He'd been married twice before and says "I saved the best for last". He and Karen have a blended family of five (5) daughters and six (6) grandchildren.

Having been a member of the Men's Golf Club and serving on the Board of Directors during the years since he moved here, he decided that it was time to step forward and serve as president. One of his goals for 2021 is to improve communications with the members and he has spent considerable time studying how to communicate via "twitter" by following President Trump.

RULES SUBMISSION by Pat Kemball

Continuing in Section Two of our journey, *Taking Relief*, we will be discussing the topic of Dropping.

When taking relief, whether with penalty or without, you must drop a ball. The ball must be dropped straight down from knee height, must be dropped by you (or your partner), must first strike the ground within your relief area, and must remain within that relief area. Your caddie is not allowed to drop your ball.

The relief area is always measured from a reference point. The reference point for an unplayable ball is simply the spot where the ball lies. For a ball in a penalty area, it is the spot where the ball crossed the edge of the penalty area. When taking relief from things like temporary water, ground under repair, cart paths, and sprinkler heads (abnormal course conditions), the reference point is called the nearest point of complete relief. This is the spot on the course nearest to where your ball lies, but not nearer the hole, where you could play your next stroke with no interference from the condition you are taking relief from.

The size of the relief area is measured from the reference point and is determined by the type of relief you are taking (one-club length for things like cart paths and ground under repair, or two club-lengths for lateral relief for an unplayable ball or a ball in a red penalty area). If the ball doesn't stay in the relief area, place a ball on the spot where it struck the ground on the second drop.

When taking relief, a club-length is always the length of the longest club in your bag (excluding your putter). For most players, this will be their driver. You may leave the head cover on when measuring, but the extra length doesn't count - the club-length is still simply the length of the driver itself.

Here are some of the most frequently asked questions from our members:

My ball won't stay in the area I need to drop it in - can I place it?

You must try two times to drop your ball in the relief area. If you have tried twice by dropping your ball correctly from knee height and into the relief area but it won't stay in the relief area, you may then place your ball where it first touched the relief area on the second drop (see Rule 14.3c(2)).

How do I correctly drop a ball?

You must drop a ball in the "right way," which means that you drop it from knee height, you don't influence how the ball will come to rest (such as by spinning the ball), and your ball doesn't touch your body or equipment before it hits the ground (see Rule 14.3b).

When do I need to drop again?

When you drop, your ball must land in and remain in the relief area. If your ball does not come to rest within the relief area, you must drop again to avoid penalty (see Rule 14.3c(2)).

Can my partner drop or replace my ball?

Yes, your partner is allowed to take any action that you are allowed to take, including dropping and replacing your ball. Nobody else is allowed to drop your ball.

What if I drop instead of replace or replace instead of drop?

If you drop instead of replace, and your ball is on the correct spot, you get a one-stroke penalty for not following the right procedure (see Rule 14.2b(2)). If it is not on the correct spot, you get the general penalty of loss of hole in match play or two strokes in stroke play (see Interpretation 14.2b(2)/1). However, if you replace instead of drop, you get the general penalty of loss of hole in match play or two strokes in stroke play (see Rule 14.3b(3)).

How do I find the nearest point of complete relief and when is it used?

The nearest point of complete relief is used for taking free relief from an abnormal course condition, a dangerous animal condition, a wrong putting green or a no play zone. It is the estimated point where the ball would lie that is nearest to the ball's original spot, not closer to the hole than that spot, in the required area of the course, and in a position where the condition you are taking relief from does not interfere with the stroke you would have made from the original spot if the condition was not there (see Definition of Nearest Point of Complete Relief).

Here are some Definitions that pertain to this section:

Definition of Drop:

To hold the ball and let go of it so that it falls through the air, with the intent for the ball to be in play. Each relief Rule identifies a specific relief area where your ball must be dropped and come to rest.

In taking relief, you must let go of the ball from a location at knee height so that the ball:

- Falls straight down, without throwing, spinning or rolling it or using any other motion that might affect where the ball will come to rest, and
- Does not touch any part of your body or equipment before it hits the ground (see Rule 14.3b).

Relief Area:

The area where you must drop a ball when taking relief under a Rule. Each relief Rule requires you to use a specific relief area whose size and location are based on these three factors:

- **Reference Point:** The point from which the size of relief area is measured.
- **Size of Relief Area Measured from Reference Point:** The relief area is either one or two club-lengths from the reference point, but with certain limits:
- **Limits on Location of Relief Area:** The location of the relief area may be limited in one or more ways so that, for example:
 - It is only in certain defined areas of the course, such as only in the general area, or not in a bunker or a penalty area,
 - It is not nearer the hole than your reference point or must be outside a penalty area or a bunker from which you are taking relief, or
 - It is where there is no interference (as defined in the particular Rule) from the condition from which you are taking relief.

Nearest Point of Complete Relief:

Your reference point for taking free relief from an abnormal course condition (Rule 16.1), dangerous animal condition (Rule 16.2), wrong green (Rule 13.1f) or no play zone (Rules 16.1f and 17.1e), or in taking relief under certain Local Rules.

It is the estimated point where your ball would lie that is:

- Nearest to your ball's original spot, but not nearer the hole than that spot,
- In the required area of the course, and
- Where the condition does not interfere with the stroke you would have made from the original spot if the condition was not there.

Estimating this reference point requires you to identify the choice of club, stance, swing and line of play you would have used for that stroke.

Instructions for determining the Most Improved Golfer

Add 12 to the player's Handicap Index at the start date. This value is A. Add 12 to the player's Handicap Index at the end date. This value is B.

Divide value A by value B, calculating to three decimal places. This is the improvement factor. The player with the highest improvement factor should receive the most improved player award.

Example:

Starting Handicap Index: 24.3 | Ending Handicap Index: 16.2

Value A: 24.3 + 12 = 36.3 | Value B: 16.2 + 12 = 28.2

A / B: 36.3 / 28.2 = 1.287

Improvement factor: 1.287
