City Golf Championship Was a Large Success!

Congratulations to Christymae Saban (women's division) from Rancho Santa Margarita and Triston Boose (men's division) from Wildomar who won the title of Canyon Lake City Champion. Their names will be engraved on the perpetual trophy that sits prominently in the display case at the Country Club lobby.

The 5th Annual Canyon Lake City Golf Championship was played the last weekend in September with a field of 58 competitors. The weather was perfect for golf with cool mornings and afternoon temperatures in the 70's. The field was divided in to 6 flights with 5 men's flights and one women's flight. It was a two day gross event where everyone competed with the actual number of strokes made. Handicaps were only used to divide the flights and allow for more competitive groupings. The men's flights were; Flight 1 - 0 to 4 handicap, Flight 2 - 5 to 9 handicap, Flight 3 - 10 to 12 handicap, Flight 4 - 13 to 18 handicap and Flight 5 - 19 handicap and above. Both men's flights 1 and 2 played from the Black tees and were competing for the City Championship title while the 3 other flights played from the Blue tees and were competing for significant prize money and, of course, bragging rights. With only 6 women in the competition they were all eligible for the City Championship title.

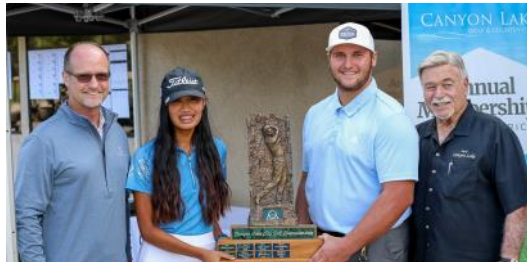

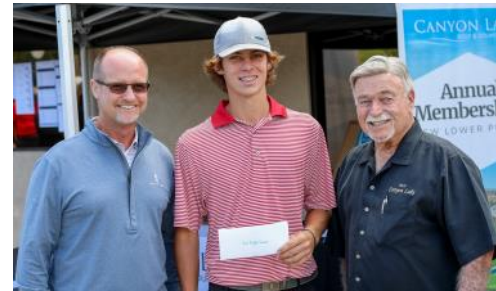

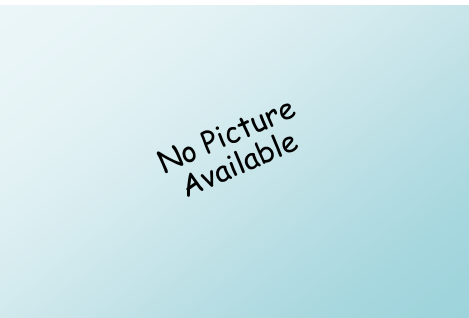

Where to Place the Bunker Rakes?

There have been a number of comments about where to place the bunker rakes so they won't affect play. The Green Committee has addressed this issue and decided to make a change. In the past the committee has adopted the USGA recommendation to place the rakes outside the bunkers. Some members felt that was a problem when a ball would strike the rake and go in the bunker or interfere with an otherwise good shot. The Green Committee discussed the option of placing the rakes at the bunker edge to avoid affecting a good shot and for easy access for the players. This wasn't a practical solution since the rake could prevent the ball from rolling to the bottom of the bunker and leave the golfer with a more difficult shot. One that might leave them to deal with the bunker edge and/or the slope.

A third option was discussed to place the rakes in the bottom of the bunkers. This would be helpful to the maintenance crew and would be the best option to keep the bunker rakes out of play but will require players to enter the bunker to retrieve the rake, rake their tracks and throw the rake back to the center of the bunker after their shot. While it is not a perfect solution the Green Committee has decided to adopt a new policy to have all bunker rakes placed in the bottom of the bunkers.

The Green Committee would like to encourage everyone to follow the recommendation and thank you all for your cooperation with the new policy and place the rakes in the bottom of the bunkers.

The Green Committee meets the second Thursday of every month at 1 pm in the Magnolia Room. We encourage you to attend if you have any questions or comments about the golf course.

Getting to Know Justin Vasquez
Assistant Golf Course Superintendent – Canyon Lake Country Club

Justin Vasquez relaxed briefly from today's task of fertilizing the newly planted Ryegrasses at Canyon Lake Country Club to share some of his thoughts with me about working at Canyon Lake Country Club.

Justin grew up in Hemet, California where his father was a struggling rancher and mother worked in a local warehouse to help the young family make ends meet. Justin and his older brother did chores on the ranch and perhaps that helped him to prepare for a life of golf course maintenance. High school days were filled with sports activities such as baseball, football and wrestling. Justin enjoyed target shooting, hunting, fishing and camping with his father and brother. But there were no indicators in early youth that he would turn to golf for his profession - *"I barely knew how to use a weed eater at the time"*.

Then, needing a job, Justin answered a ValleyCrest Golf Course Maintenance ad for

part time help at Canyon Lake Country Club. Mark Wilson, Superintendent at that time hired Justin. After employed for a couple of months, Justin found that he really enjoyed the tasks and work ambience at the golf course. He started to ask questions and to pick Mark Wilson's brain to learn more. But then the Marks changed and Mark Louder replaced Mark Wilson. Louder was exactly who Justin needed as a mentor and teacher to continue his professional growth. Justin noted, *"Mark Louder has taught him practically everything he has learned. He has been an awesome mentor"*.

So began a period of intensive training by hand-on job performance – daily course set up; fairway, green & tee mowing; removing weeds on property lines and around flower beds; edging cart paths and bunker edges; assisting with irrigation system repairs; and, all tasks related to golf course maintenance. Within a couple of years he had advanced to landscaping assignments; maintenance and repair of equipment; record keeping for fertilizer and chemical usage; developing irrigation strategies; working with Men's and Women's golf committees and supervision of crews on various projects.

At this time, Justin accepted an opportunity to work in the construction industry but quickly realized that he didn't enjoy the work as much as the golf course challenges he had faced at Canyon Lake so he switched to a neighboring RV Park with an 18-hole Executive Golf Course. Learning that Mark Louder was seeking to hire an Irrigation Technician, Justin applied and once again returned to the Canyon Lake CC maintenance team. With Mark's guidance, Justin began to attend classes at Mount San Jacinto College to further advance his skills and knowledge in Turf Management and Arboriculture, ultimately completing his 2-year certificate in 2017. BrightView Golf Course Maintenance rewarded this accomplishment with the title of Assistant Superintendent.

Justin continues to live in nearby Hemet with his wife Sabrina. The couple has two daughters, 7 years and 15 months old and are expecting a third. Sabrina is a care giver for aging parents and the young family and Justin's spare time for hobbies and sports has quite understandably taken a back seat to family time.

I asked Justin to review what would be a typical work day for him. Justin is usually the first employee to arrive in the morning to open the shop and break room and to adjust the work board daily task assignments. He leads *"crew huddles"*, guides *"morning stretches"* and oversees *"equipment readiness gate checks"*. Once the daily crew tasks are underway, Justin tours the course observing moisture levels, irrigation problems, insect or disease issues and unusual conditions requiring attention.

When I asked Justin what makes an Assistant Superintendent successful he didn't hesitate to respond as follows: *"knowledge of the golf course; confidence of the Superintendent; respect from fellow crew members; and a reliable, hard-working crew who are all on the same page"*. I couldn't have said it any better! Justin also noted that *"although I love it here, the people are friendly, the crew is awesome and I don't need much supervision, I have set a goal of becoming a Superintendent by age 35"*. It will be bittersweet for all when that goal is met. Thanks Justin.

November Bulletin Rules Submission

In this issue we will be covering relief from **Immovable Obstructions** and relief from a **No Play Zone**. This will be specific to the play of hole #10 with reference to the teeing area of hole #11.

There have been many questions regarding the proper way to proceed when your ball comes to rest on or around the teeing area on hole #11 when playing #10. I hope the following explanation will help with understanding how to proceed when your ball comes to rest on the cart path, in the area that has the ball washer and hole monument, in the planter toward the back of the tee or is next to the rock wall.

Here are the definitions that we will be covering for the explanation of the rule and relief procedures:

Abnormal course conditions:

Is any of these four defined conditions:

- Animal Hole,
- Ground Under Repair,
- Immovable Obstruction, or
- Temporary Water.

Obstruction:

Any artificial object except for integral objects and boundary objects.

Examples of obstructions:

- Artificially surfaced roads and paths, including their artificial borders.
- Buildings and rain shelters.
- Sprinkler heads, drains and irrigation of control boxes.
- Stakes, walls, railings and fences (but not when they are boundary objects that define or show the boundary edge of the course).
- Golf carts, mowers, cars or other vehicles.
- Waste containers, signposts and benches.
- Player equipment, flagsticks and rakes.

An obstruction is either a movable obstruction or an immovable obstruction.

If part of an immovable obstruction (such as a gate or door or part of an attached cable) meets the definition of a movable obstruction that part is treated as a movable obstruction.

Immovable obstructions:

Any obstruction that:

- Cannot be moved without reasonable effort or without damaging the obstruction or the course, and
- Otherwise does not meet the definition of a movable obstruction.



All of these pictures are examples of immovable obstructions around the 11th teeing ground.

Nearest point of Complete Relief:

The reference point for taking relief from an abnormal course condition (Rule 16.1) or no play zone (Rules 16.1f).

It is the estimated point where the ball would lie that is:

- Nearest to the ball's original spot, **but** not nearer the hole than that spot,
- In the required area of the course, and
- Where the condition does not interfere with the stroke the player would have made from the original spot if the condition was not there.

Estimating this reference point requires the player to identify the choice of club, stance, swing and line of play he or she would have used for that stroke.

The player does not need to simulate that stroke by taking an actual stance and swinging with the chosen club (**but** it is recommended that the player normally do this to help in making an accurate estimate.)

The nearest point of complete relief relates solely to the particular condition from which relief is being taken and may be in a location where there is interference by something else:

- If the player takes relief and then has interference by another condition from which relief is allowed, the player may take relief again by determining a new nearest point of complete relief from the new condition.
- Relief must be taken separately for each condition, **except** that the player may take relief from both conditions at the same time (based on determining the nearest point of complete relief from both) when, having already taken relief separately from each condition, it becomes reasonable to conclude that continuing to do so will result in continued interference by one or the other.

No play zones:

A part of the course where the Committee has prohibited play. A no play zone must be defined as part of either an abnormal course condition or a penalty area.

The committee may use no play zones for any reason, such as:

- Protecting wildlife, animal habitats, and environmentally sensitive areas,
- Preventing damage to young trees, flower beds, turf nurseries, re-turfed areas or other planted areas,
- Protecting players from danger, and
- Preserving sites of historical or cultural interest.

The committee should define the edge of a no play zone with a line or stakes, and the line or stake (or tops of those stakes) should identify the no play zone as different than a regular abnormal course condition or penalty area that does not contain a no play zone.



This planter area will be played as a no play zone, it will be marked with a white line and play is prohibited from within the planter and if the planter area interferes with your stance or intended swing you **must** take complete relief from the situation.

When your ball comes to rest in, on or near these obstructions and your stance or your intended swing is interfered with you may take free relief from the immovable obstruction.

Rule 16.1

Please remember that you do not have to take relief from the immovable obstruction and you may chose to play the ball as it lies. This may sometimes occur when the nearest point of complete relief is in an area that may be worse than where the ball originally lay.

Always remember to mark and leave the ball in it's original position until you determine where the nearest point of complete relief will be. If you lift your ball prior to determining the nearest point of complete relief you must take relief on that point.

When your ball comes to rest in, on or near the planter that is marked as a no play zone you must take relief from the planter. If your ball is outside the planter area and it interferes with your stance or intended swing you must take complete relief from the planter. **Rule 16.1f**

When taking free relief from an immovable obstruction or no play zone you must first determine your nearest point of complete relief. Once you have determined this point you will use your driver to measure the relief area which is one driver length from the point of nearest relief not nearer the hole. The ball or another ball may be dropped from knee height and must stay in the relief area. If the ball touches the relief area and then rolls outside of the area it must be dropped a second time, if it rolls out of the area again it must be placed on the spot it first touched the ground in the relief area.

I hope this will help with some of the situations that may occur while playing the 10th hole. If you ever have any questions on how to proceed please do not hesitate to ask me at anytime.

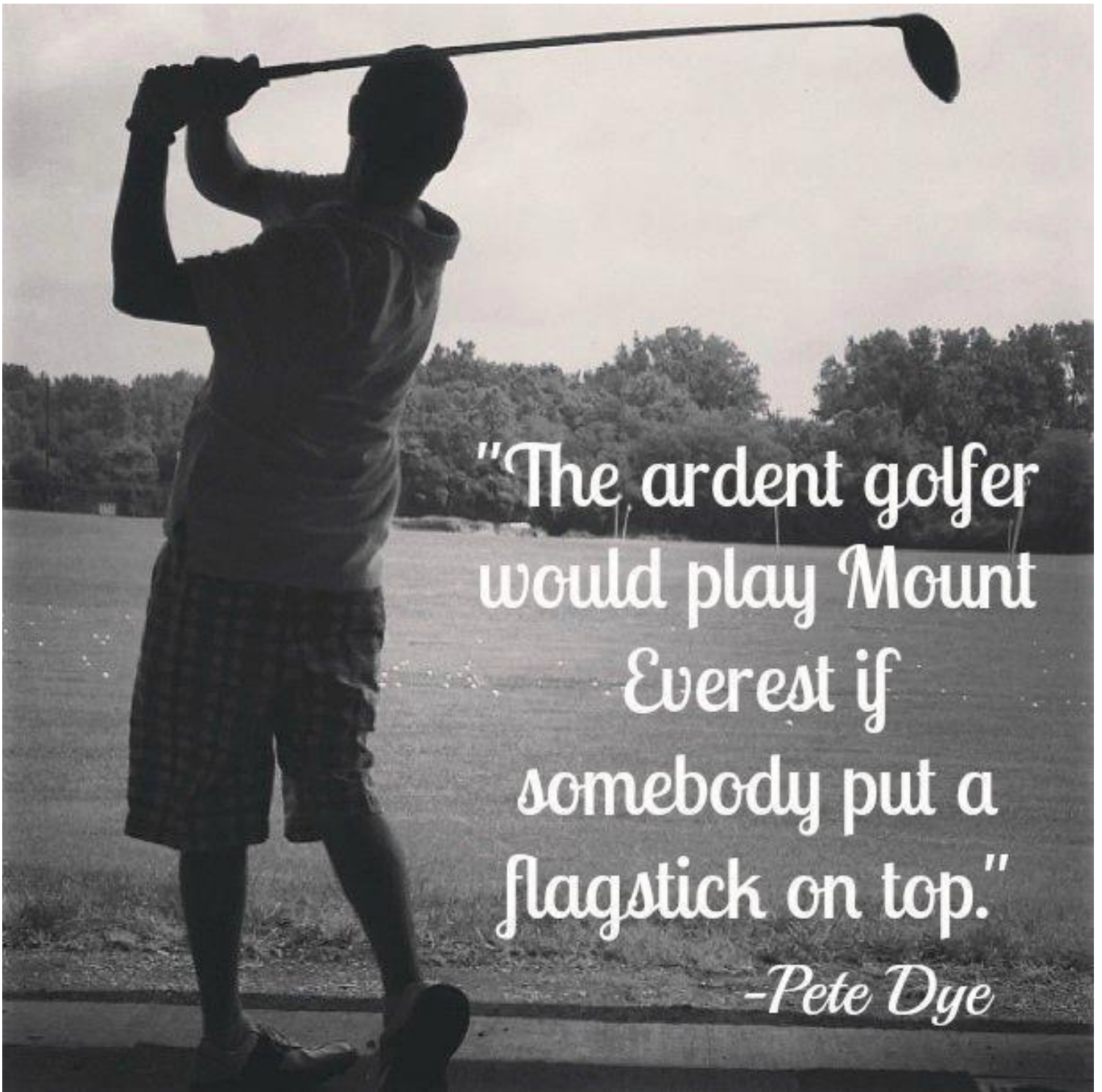
