**ANNUAL GOLF MEMBER'S AGREEMENT**

The Member(s) shall be obligated to pay all charges for annual golf specified in this Agreement, until the end of the term of this Agreement, without exception. This Agreement may not be assigned or rescinded early by the Member(s) for any reason.

**Member Annual Commitment**

I/we understand that by entering this Agreement, I/we am/are obligated to pay the entire annual charge(s). I/we understand we are obligated to pay the annual charges(s) regardless of any circumstance, including, but not limited to, desire to discontinue utilizing the golf course, inability to utilize the golf course, personal or financial hardship, closure of all or any portion of the golf course, or any other reason. I/we further understand that this agreement constitutes a purchase contract, and therefore cancellation is subject to review on a case by case basis.

**Member Cancellation and Refund**

Requests for cancellation of this agreement will only be considered if the member has a medical condition which prevents use of the Golf Course and Driving Range. In order to be considered, the member must submit a written request for refund as well as a doctor's note which identifies the member's inability to continue to play golf. This request must be sent to the Canyon Lake POA Corporate Office. The refund will be calculated using a straight line methodology and will be based on the DATE OF THE DOCTOR'S NOTE.

**Membership and Facility Use**

Purchase of an annual golf membership does not constitute membership within the Canyon Lake POA. Therefore, annual golf members are only authorized to use / access the golf course, Pro Shop, and Country Club.

**ANNUAL GOLF MEMBER'S AGREEMENT - cont.**

- I/We agree to use the golf course and related facilities in accordance with the terms of this Agreement and all governing documents of the Canyon Lake POA, including but not limited to any rules as may be adopted from time to time by the Board of Directors. I/we understand that failure to abide by any applicable restriction could result in a loss of member privileges, including, but not limited to, a loss of golf course use privileges.
  
- I/We specifically acknowledge the Canyon Lake POA's Member in Good Standing policy provides that any member's failure to maintain status as a member in good standing may result in suspension of recreational amenity use privileges, including golf course privileges. An annual golf member will not be entitled to any refund, offset or proration of annual golf fees if he or she is suspended pursuant to the Canyon Lake POA's Member in Good Standing policy.

**MEMBERSHIP PRIVILEGES**

The following information highlights some of the privileges that Canyon Lake Golf & Country Club Members enjoy.

- Members have access to unlimited golf with shared golf cart included.
- Members receive discounted rates on club tournaments.
- Members receive a 20% discount on select merchandise in the Golf Shop.

**PAYMENT INFORMATION**

Your membership dues go a long way in keeping the golf course maintained. It is important to pay your bill on time each month so that we can keep our course in good condition for you and the other members.

- Canyon Lake Golf & Country Club membership requires a 12 month commitment from the time of purchase.
- Membership dues cannot be suspended while a member is out of town or otherwise unable to play for a short period of time.
- Membership charges accrue as long as membership continues.
- Membership continues until notice of cancellation is received in writing 30 days before the end of the contract.
- Charges incurred prior to cancellation remain payable after cancellation.
- Dues are payable upon receipt.
- A late fee is applied to balances overdue more than 30 days.
- Dues can be paid by any of the following methods:
  - By credit card or check (for annual payment option)
  - With our automatic payment system "APS" (for monthly payment option, first month down)
- Playing privileges are revoked after dues are 60 days overdue.
- We reserve the right to revoke membership privileges for chronic late payments less than 60 days.
- Memberships more than 90 days late are terminated. All past dues remain payable.

## GOLF COURSE RULES

### GOLF COURSE RULES FOR MEMBERS

**Use Privileges – Defined** – Members in Good Standing are allowed daily use of the golf course and related facilities in accordance with hours, procedures and restrictions, as stated in these rules.

**Non-Resident Memberships** – Non-Resident Golf Memberships are available to Non-Members of the Canyon Lake POA pursuant to the Canyon Lake POA's revocable membership agreement. A non-resident Golf Member in compliance with these rules and all provisions of his/her revocable Golf Membership Agreement shall also be considered a member in good standing for purpose of golf course and country club facilities use only. No other privileges are afforded to non-resident Golf Members.

**Limitations** – The following are limitations for guests of members.

- Member in Good Standing Required. Member must be a member in Good Standing in order to extend golf course use privileges to guests.
- Maximum Number of Guests per Member. Maximum number of guests per member is four at any one time.
- Exception: The Golf Professional may schedule Member-sponsored coordinated groups of 12 or more.
- Members Guest Play Frequency. Any one of a members guest may only play two times per month.

**Reciprocal Play (Non-Members)** – Defined as persons who are Members of other private golf courses where reciprocal play privileges are extended.

- Cash or Credit Card only for Fees - Appropriate fees shall be satisfied on individual cash or credit card basis only.
- Proof of Membership - At time of play, individual must show proof of current membership of said golf entity.
- Reservations - Reservations are required.

**Non-Members** – The golf course is closed to outside play with the following exceptions:

- Guests of members
- Reciprocal play
- Sanctioned tournament play
- Member sponsored / coordinated organized play
- Non-Members with an approved CLPOA Annual Revocable Golf Membership
- Schools team members

### GOLF COURSE RULES FOR USE AND PLAY

Rules and regulations have been established by Canyon Lake POA for use and play. These rules are to be adhered to by all. Any violations of the rules may result in applicable fine(s). Any violation of the rules could also result in the loss of golfing privileges.

- **Registration and/or Payment** – All players must first register in the Golf Shop. The non-member fee rate will be charged to those unable to show evidence of membership (Canyon Lake POA Membership Card).
- **Junior Players** – Junior players, unaccompanied by an adult, may play the course provided they can show evidence of knowledge of all safe golfing practices. Note: Pro Shop to have written record of evidence.
- **Start** – All players will start on the first tee unless otherwise permitted by the starter.
- **Fivesomes** – No fivesomes are permitted without specific permission from the Golf Shop.
- **Practice** – Practice is limited to the Practice Facility. Only practice ball supplied by the Golf Shop are to be used on the driving range. Practice balls, baskets, or bags are not to be removed from the practice facility.
- **Stopping** – Persons stopping between nines must check in with the starter before resuming play.
- **Falling Behind/Play Through** – Groups falling more than one hole behind must allow following group to play through.
- **No Fighting or Misconduct** – Fighting or misconduct of any kind is subject to applicable fine and suspension of golf privileges.
- **Replace Divots, Rake Bunkers and Repair Ball Markers, As Needed** – Divots on tees and fairways must be replaced, bunkers raked and ball marks on the greens repaired. This rule applies to all golfers – walking or using golf carts.
- **No Swimming, Fishing or Wading in Golf Course Lakes** – No swimming, fishing or wading is permitted in golf course lakes. Players; balls must be retrieved from shore.
- **No Pets on Golf Course** – Pets are not allowed on the golf course at any time (on leash or otherwise).

GOLF COURSE RULES FOR USE AND PLAY - cont.

- **Only Authorized Persons Allowed on Golf Course and / or Cart Paths** – No persons except registered golfers, maintenance/ supervisory personnel or authorized spectators are permitted on golf course or cart paths. Cart paths cannot be used to commute from one side of the community to the other.
- **Only Authorized Golf Carts Allowed on Golf Course** – No personal vehicles other than authorized golf carts allowed on golf course.
- **Bicycles, Skateboards, Scooters, Inline Skates** – No bicycles, skateboards, scooters or inline skates are allowed on the golf course or cart paths.

GOLF CART RULES

These rules have been established by Canyon Lake POA and are to be adhered to by all. Any violation of the rules may result in applicable fine(s). Further, any violation of the rules could also result in the loss of golfing privileges.

- **Golf carts pose a serious problem for the rough and fairway turf grass** - They compact the soil, leave ruts in the turf in wet areas and damage new growth. As a result the following rules have been established for golf carts:
- **Drivers License Required** – No person without a valid Driver License is permitted to operate any golf cart at any time on the golf course.
- **Authorized Use Only** – No one shall be permitted to ride in carts without permission from the Golf Shop unless playing golf. A fee may apply.
- **Ninety Degree Rule in Effect** – The ninety degree rule is in effect at all times. If this is unfamiliar, ask at the Golf Shop.
- **Maximum Two Persons per cart/ Maximum Two Carts per Foursome** – Two persons per cart, maximum two carts per foursome.
- **No Carts on Steep Hills** – Golf carts are not allowed on steep hills.
- **Stay on Paths** – Golf carts must be kept on paths except to go to the ball.
- **Stay of Teeing Ground** – Golf carts must stay off all teeing grounds.
- **Stay and/or Park on Cart Path around Tees and Greens** – Stay and /or park on the cart path around tees and greens. Keep all four tires on the cart path at all times.
- **No Parking in Front of Greens** – Golf carts may not be parked in front of greens.
- **Maintain Required Distance from Greens** - Golf carts must be kept at least twenty yards away from greens.
- **Maintain Required Distance from Greens for Carts with Authorized Medical Flag** – Carts with authorized medical flags must go no closer than fifteen yards to greens or tees.
- **Carts without Turf-Friendly Tires Allowed on Cart Paths Only** – Carts without turf friendly tires must remain on cart paths at all times.

- The Southern California Golf Association (SCGA) membership may be purchased through one of our member clubs.
- SCGA membership is open to all golfers, men and women, boys and girls.
- SCGA members can play in SCGA and Canyon Lake Golf & Country Club tournaments, and we keep your handicap. To have an accurate handicap and ensure a level playing field, you must turn in every scorecard (even from other courses) and play by USGA rules, such as not improving your lie.
